consistently speaking out against the violation of freedom by any other nation in the world.

Our condolences go to Mrs. Palme, their children and the people of Sweden. Sweden has lost a great Prime Minister. The world has lost a determined champion of freedom, equality and peace.

Some Hon. Members: Hear, hear!

Mr. Speaker: I am sure the House would want to express its memory and its respect in the usual way.

#### MASSEY FERGUSON

Question No. 498-Mr. Kaplan:

Was the guarantee fee which Massey Ferguson agreed to pay the Government for its loan guarantee in the 1985 fiscal year waived and, if so (a) for what reason (b) what is the revenue loss expected to be?

Mrs. Monique B. Tardif (Parliamentary Secretary to Minister of Regional Industrial Expansion): (a) Yes, based on a commitment by the previous Government in February, 1983, associated with Massey Ferguson's 1983 refinancing.

(b) \$312,500 in fees payable less \$78,000 in consulting fees incurred by the Government in respect of the refinancing which Massey Ferguson agreed to pay, for a net cost of \$234,500.
