

CIVIL RIGHTS ALLIANCE.

OBJECTS.—The constitutional resistance of the efforts of any organization to violate the principles of Civil Liberty; the guidance and protection of persons whose rights of Citizenship may be infringed by Ecclesiastical or any other agency; the liberation of national funds from the control of any religious establishment; and the abrogation of all public patronage, exemptions, privileges and powers which contravene the spirit of religious equality.

The methods by which these objects are being promoted are controlled by a Council and directed by an Executive,—
the latter being assisted by Parliamentary,
Municipal, Educational, Law, Privileges
and Finance Committees.
