A.102 No. Q.103 Did you see either on a later date in connection with the A.103 No, sir. Q.104 Had either of these accused been working for you on this particular job previous times? A.104 Yes, I think they both were during the Summer months. Q.105 I will show you Exhibit "B" can you identify the signature and writing? A.105 I can, sir. The writing is that of Cpl. Lewis. The signature is that of Lieut. Morton.
Q.106 Can you identify this signature positively as Lieut. A.E. Mortons? A.106 Yes, dr. The witness is cross-examined by the Defending Officer for

Q.107 You state that when you give the boys a slip you enter what was on the slip in your book? Yes, sir. Q.108 Was there a day when you gave the boys two or three slips at one time? A.108 No, sir. Q.109 When they returned from delivering a load of wood, you referred to your note book to see what load was taken and how much was due to you. A.109 Yes, sir. Q.110 You made a statement that Pte, Howes returned to you £2-14-6. You referred then to your notebook when he came in and he paid you £2-14-6? A.110 Yes, sir.

Q.111 After Lieut. Morton had commented to you that something was wrong and you went and got Pte. Howes, did Pte. Howes on any occasion tell you that a mistake had been made and he was going to mrits right it?
A.lll He did, sir.
Q.ll2 When did he tell you this?
A.ll2 On the morning of 25 Nov 44. The day after the wood was

delivered.

Q.113 Did you inform Lieut. Morton of this?

Q.113 Did you inform bleut. Morton of this?
A.113 Lieut. Morton knew about it, sir.
Q.114 Did you give Pte. Howes any advice in the matter?
A.114 No, sir. I didn't. It was out of my hands at the time.
Q.115 In regard to Exhibit "B". You say that you got that slip from the Orderly Room on 22 Nov 44 and that you took it to your own office. Did you have a clerk in your office. A.115 No.

Q.116 You locked it in the safe?

A.116 Yes, sir.

Q.117 Has anyone else a key? A.117 No, sir.
