"Personal expenses." The expression "Personal Expenses" as used in The Dominion Elections Act (1900) with respect to the expenses of any candidate in relation to the election at which he is a candidate, includes, unless the context otherwise requires, "The reasonable travelling expenses of such candidate and the reasonable expenses of his living at hotels, or otherwise, for the purpose of and in relation to such election." sec. 3, sub-sec. i.)

"Personation," is defined by "The Ontario Election Act," sec. 167 (2) as follows:—

- (2) A person shall be deemed to be guilty of the offence of personation who, at an election, applies for a ballot paper in the name of some other person whether that name be that of a person living or dead, or of a fictitious person, or who having voted once at an election applies at the same election for a ballot paper in his own name, and every such person shall incur a penalty of \$400, and shall also on conviction be imprisoned for a term of one year with or without hard labour. 55 Vict., ch. 3, sec. 159 (2); 57 Vict., ch. 7, sec. 12; 63 Vict., ch. 4, sec. 24.

"Personation." The Dominion Elections Act (1900) indicates section 114 that "Every person who at an election (a) applies for a ballot paper in the name of some other person, whether such name is that of a person living or dead, or of a fictitious person; or (b) having voted once at any such election applies at the same election for a ballot paper in his own name, is guilty of personation"

"Polling Division" is defined by The Franchise Act, 1898, to include, when used in reference to Provincial Elections, unless the context otherwise requires "any polling sub-division, polling district or sub-division or other territorial area for which there is a separate voters list, or in which a poll may be held." (Sec. 4, sub-sec. e.)

"Polling division" is defined by The Dominion Elections Act (1900) to include, unless the context otherwise requires, "Any polling sub-division, polling district or sub-district or other territorial area for which there is a separate voters list, or in which a poll may be held." (Sec. 3, sub-sec. e.)

Polling place. Persons entitled or to be permitted under The Ontario Election Act, to be present in a polling place during the time appointed for polling are those only who are "officers, candidates, clerks or agents authorized to attend at such polling place and such persons as are for the time being actually engaged in voting," but it is "at all times lawful" for the D.R.O. to have present, or to summon to his assistance in the polling place, any police constable or peace officer
