

PROF. TRENHOLME DIES IN MISSOURI

Was in University History Department Here in 1900 and 1901.

The death took place recently at Columbia, Mo., of Professor Norman MacLaren Trenholme, chairman of the department of history in the University of Missouri, who in 1900 and 1901 was professor of history in Western university. There are many in London who will remember the young teacher who came here from Harvard, though of the present faculty of the university Dr. N. C. James is the only one who was on the staff at that time.

Dr. Trenholme was born in Montreal in 1874, his father being a judge of the court of king's bench in the province of Quebec. He was educated at McGill and Harvard, receiving the degree of Ph.D. from the latter institution in 1899, after which he spent two years in graduate work and travel in Europe.

After leaving Western university, Dr. Trenholme was for a year on the staff of Pennsylvania state college and then went to the University of Missouri, where in 1905 he became chairman of the department of history. In 1919 he was appointed chairman of the junior college committee. He was the author of several books in the field of history and a frequent contributor to the historical magazines. He was a member of the American Historical association, the Mississippi Valley Historical association, and the Royal Historical society of Great Britain.

His first wife was Ida Ethel Hurst, of Montreal, to whom he was married in 1901. She died in 1917. In 1923 he was married to Anna Louise Ivey of Atlanta, Ga. Eight children survive.

The Columbia Missourian, in paying tribute to the death of Dr. Trenholme, says that "probably no man in the state has done more for the advancement of the teaching of history in Missouri." He is survived by four sons and one daughter. The funeral is being held today.

EVANGELIST'S FATHER DIES IN CAPE BRETON

Donald Matheson Passes Away at the Age of 95 Years.

Evangelist William Matheson has just received word of the death of his aged father, Donald Matheson, at the age of nearly 95 years, in his old home at Cape Breton, N.S. Evangelist and Mrs. Matheson had just returned three weeks ago from spending a month with him. They left him very feeble, but bright in mind as ever. He was born in Cape Breton and his father came from the highlands of Scotland and was one of the first settlers in that part of the country. He is survived by four sons and one daughter. The funeral is being held today.

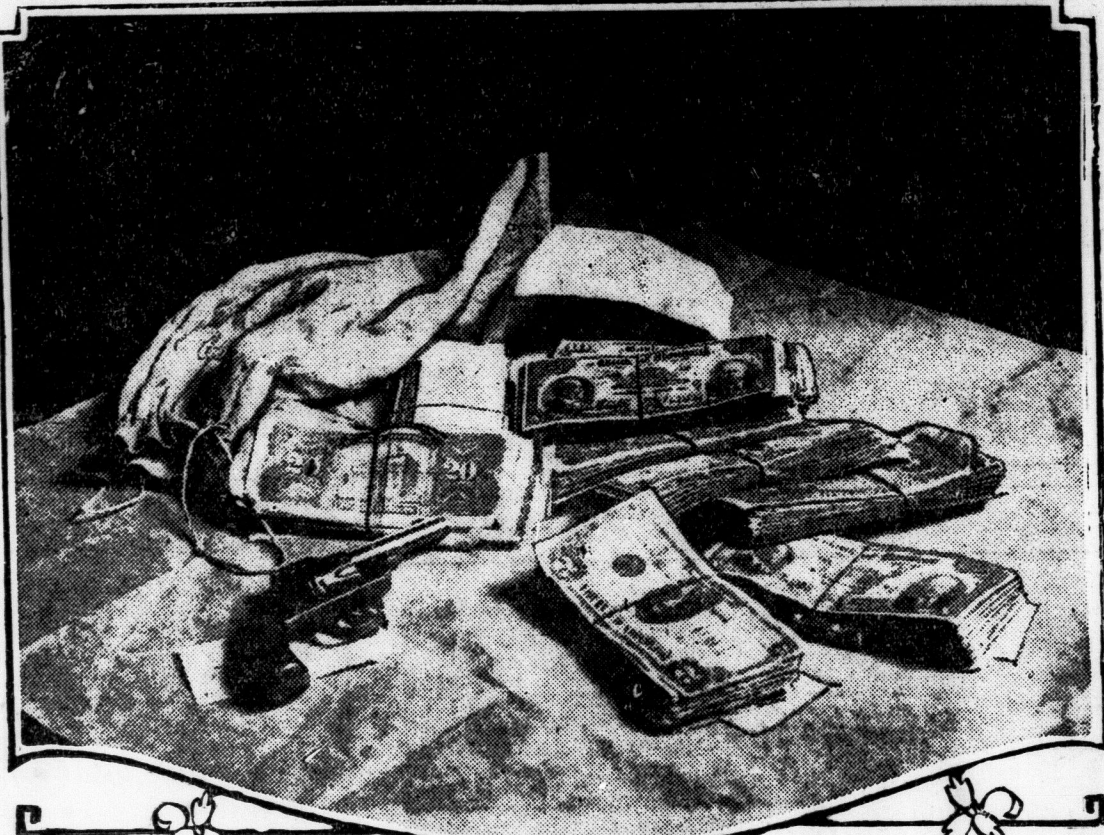

HATHEWAY RETURNS IN CAR USED IN ROBBERY

Looks Anything But Daring Bandit As He Reaches County Jail.

EXPRESSES SORROW Declares en Route That He Was Alone When the Job Pulled.

Leslie Hatheaway, self-confessed Thorndale bank bandit, returned to London yesterday afternoon in the McLaughlin car purchased with Bank of Montreal bills he had stolen from the Thorndale branch of the bank on July 3. Hatheaway looked anything but a daring desperado as he stroled down the courthouse corridor to the jail door a few minutes after 6 o'clock.

The door swung open slowly, and Hatheaway got a good look at formidable jail bars. He paled perceptibly under his heavy coat of tan, but stepped forward silently when Inspector Miller motioned him in with a wave of his hand. Then the door clanged shut on the Beau Brummell bandit, garbed in a neat blue suit, tie and socks to match and a sporty gray fedora hat, which had stood him in good stead two minutes before, shielding his face from a battery of cameras on the walk in front of the courthouse.

The bandit left Toronto yesterday afternoon at 2:40 in the taxi seat of his own car. Inspector Miller, who recently returned home from California with Andy Papali, sat beside him, while Constable Mennie and Bank of Montreal inspector occupied the front seat.

The prisoner thought Mennie was merely the chauffeur, and did not seem to realize that the expert driver of the car was the man responsible for his apprehension. Warned by his Toronto counsel, R. H. Greer, K.C., not to say anything, Hatheaway was silent during most of the speedy journey.

Made Three Trips. He announced that the road to London was quite familiar to him, as he had made the trip three times since the robbery.

Like the majority of criminals when caught, the lone bandit expressed sorrow for his actions.

"I'm sorry I did it," he said. "I realize now that it was a blunder. It was my first and last holdup. I am cured."

"I'm not claiming the bank robber championship, that's one thing sure," he announced later with a half smile. "Anyone with you when you pulled the job" quizzed the police.

"Not a soul," replied Hatheaway, shaking his head. "They don't give me a damn bit of credit for doing a good job. I was all by myself."

Asked as to what had become of the \$2,100 not recovered by the police, the prisoner replied that most of it had gone in poker games. "Easy come, easy go," he quoted with another smile.

Spent Only \$1,400. The bank inspector informed the Advertiser that the amount stolen from the bank was "under \$6,000." This means that after deducting the \$700 paid to Silverwoods, Ltd., for his car the young man actually spent but \$1,400 of the money he gained at the point of his Smith-Wesson .34 revolver. He purchased a new wheel for his car while holidaying in Fenelon Falls, and the rest went in poker games and incidental expenses.

The \$3,500 was brought to London by Constable Mennie in a paper package. Later it was removed to a safety deposit vault, where it will stay until needed as evidence.

Contrary to expectations, Hatheaway was not placed in what is known in jail circles as the Murrell case. He was placed in the cell opposite to the one occupied by the famous Melbourne bank bandit and used at the time of the Murrell trial by "Slim" Williams. With him are three prisoners, to whom Hatheaway had nothing to say.

After a short conference with Crown Attorney Judd, Constable Mennie left for home and a much-needed sleep, the first he had had since last Friday.

was taken to the provincial police headquarters in Queen's park. After a short call at Deputy Aft. Cuddy's office Inspector Miller was about to handcuff Hatheaway for the trip to London.

"Please don't do that," begged Hatheaway. "I'm going to be a good boy now."

Inspector Miller upon this request placed only one bracelet on one of Hatheaway's wrists, snapping the other on one of his own. "All right," he remarked jocularly, "we'll sit together."

Will Get Merit Mark. Constable Craddock is given high praise by Inspector Frank Crowe of Dundas west station for his alertness and vigilance in sighting the car. It is a coincidence that he took the place of Constable William Pogue, transferred to East Toronto. Pogue is the man who stopped Roy Hulise on Danforth avenue three years ago, which led to the arrest of the famous Conley-Hotrum-McFadden gang.

Craddock is not entitled to participate in any rewards, as it is against the rules of the Toronto police force. "Under the rules and regulations no member of the force can accept a reward," stated Acting Chief Beatty. "But it is a certainty Craddock will be recommended for a merit mark."

Provincial Constable Mennie, who had charge of the case in London, and who wired the Toronto police the automobile license number, cannot share in the reward as it is against provincial police regulations to take rewards.

"I think if the banks are going to pay a reward for Hatheaway it should go to Mrs. Roger at St. David's," said Deputy Commissioner of Police Cuddy. "She is the woman that deserves anything that the banks can do for her. She should get the two rewards."

Mrs. Hatheaway did not visit her husband in the cells during the time that he was imprisoned there, according to police officials.

Wife Is Silent.

When The Advertiser met Mrs. Hatheaway at Toronto headquarters on Monday, she had just said goodbye to her husband after his appearance in police court. "I do not want to talk about the matter," she said. "I will not talk at all," and she walked away with her brother-in-law-to-be, a lawyer from Peterboro.

CELEBRATION MARKS BIRTH OF BABY TO MUMTAZ BEGUM

London, July 21.—A despatch to the Daily Express from Bombay says that Mumtaz Begum, former dancing girl, and favorite of the Maharajah of Indore, gave birth to a daughter yesterday. The customary celebrations in honor of the birth of the child were numerous attended. These present included Mumtaz's great-grandmother, who is reputed to be 129 years old.

Mumtaz Begum gained much notoriety last May during the trial by the Bombay high court of nine persons accused of murdering Abdul Kadir Baidar, a Bombay merchant, who had befriended Mumtaz after she fled from the palace of the maharajah and took up her residence in the home of a merchant.

It was charged at the trial that the men in the party which assassinated Baidar had been sent by emissaries of the maharajah to Bombay to kidnap Mumtaz and take her back to the maharajah. Three of the men in the party were sentenced to death.

MAY PAY CLAIMS AT MARKET BRANCH

Payments of Home Bank Cash Will Not Start For Some Days.

Claims on the defunct Home Bank will not be paid for a while yet, according to U. A. Buchner, representing the depositors here.

It is possible that when the depositors do receive their share of the money it will be paid through the market branch of the Bank of Montreal. Mr. Buchner said this morning that he had recommended that this be done as that bank was the only one in London that had four paying windows to accommodate the rush that will take place the day payment is made.

Explaining why the payments would not be made for a few days, Mr. Buchner pointed out that there are about 60,000 depositors in all. Of these, 47,000 had less than \$500 in the bank when the crash came. It will take some time for a large office staff to go over all the claims.

When the 25 per cent payment was made a staff of 40 clerks was required to handle the work. The present method of sorting out and investigating all claims under \$500 will require a greater staff and a longer time to complete the work.

The act for the relief of certain Home Bank creditors states that any creditor failing to take advantage of this act within 12 months from the date of its passing shall be absolutely barred from receiving any benefit therefrom.

The liquidators of the bank will go into each claim. When this has been completed the claims will be made in duplicate. One will be sent to a bank in the vicinity of the depositor so that he may collect his money. It will be so arranged that payments will all be made on the same day. That is, the depositor in London will receive his money at the same time the man in Winnipeg and Vancouver receives his money.

TORONTO STATIONS TUNING IN BETTER

Broadcasts From CFCA Not So Difficult To Get Now.

That radio reception from Toronto stations is better than in the past is in evidence in London and district. The Toronto broadcasts are hard to get in this district, but lately they are easier for the local fans to tune in on.

Recent broadcasts from the Toronto Star's station, (C. F. C. A.) have been received here easily, despite the fact that it summertime when radio reception is not up to par.

Local fans state that the Queen City stations do not seem to have the volume that other stations have, and the consequence is that the Toronto broadcasts are crowded out.

LATE JOHN G. JONES WILL BE BURIED TODAY

The funeral of the late John Gillespie Jones was held from his late residence, 774 Wellington street this afternoon to Woodland cemetery. Rev. James MacKay of the New St. James' Presbyterian church, officiated.

The late Mr. Jones was born in Scotland, coming to Canada 45 years ago. He entered the employ of the G. T. R. At various times during his railroad career he was stationed in Montreal and Portland, Maine. Upon his retirement in 1917 he came to London to live. Last Tuesday he left on a visit to Portland, and died suddenly there Saturday.

He was a member of the New St. James' church, and was a Free Mason. He is survived by his widow.

STEAMER AFIRE. Associated Press Despatch. Queenstown, July 21.—Wireless reports from the British steamer Scythian proceeding for Queenstown, with a fire in her cargo between decks, say the fire will probably be extinguished before she arrives here. The steamer is due today.

GAS SERVICE LOSS HOTLY PROTESTED

Residents of Brick Street and Pipe Line Road Hold Meeting.

Twenty natural gas consumers residing on the Pipe Line road and Brick street, attended a meeting in the county council chambers last night protesting the decision of the Southern Gas Company to increase service rates. Declaring that the company was at a loss to operate these mains, in which there are eighty consumers, the company asked the government to discontinue the service.

R. R. Harkness, of the natural gas commission, heard the consumers' protests, and stated he would do his best to lay them plainly before the commission. Although he could forecast no outcome, he thought that the people would be given a sympathetic hearing.

One member stated the consumers should be considered. The residents of these two districts have taken

trouble to install gas equipment, and he did not think it fair to have the company cut them out of the system. Mr. Harkness in explaining the company's case, told those present of the drop in amount of gas used over the system. When the mains were laid, nearly eleven billion cubic feet of gas was used. Later on this increased to nearly fifteen billion, and at the present time it is only about four billion.

One resident stated that one reason that people had moved into that section of the county was for the convenience of natural gas. The price of the gas was first set at 40 cents per thousand square feet. At present the users are paying 90 cents for the same quantity.

C. W. Few, secretary of the Brewery workers' union, explained that the Carling Company is not living up to the agreement of \$21 minimum made fourteen years ago. A committee was named to meet the officials of the company, the date of the conference to be arranged, when every effort will be made by the committee to have the company carry out the terms of the agreement made with the workers.

The council decided that an open-air euchre party and dance on the green should be held on Friday, July 21, at the home of Mrs. Floyd Wells, 491 Horton street, president of the London women's labor party, in aid of the Nova Scotia striking miners.
