# DOWNGRADING OF POSITIONS OF SENIOR OFFICERS-RECONSTITUTING OF COMMITTEE

Mr. G. W. Baldwin (Peace River): As it appears quite certain that the efficiency and effectiveness of the staff of the Auditor General are being greatly impaired, will the government review the entire situation with a view to reconstituting the government committee which was examining this matter?

**Mr. Baldwin:** I am directing my supplementary question to the President of the Privy Council who apparently is answering today for the President of the Treasury Board. Will the minister discuss with the President of the Treasury Board the immediate necessity of reconstituting the government committee which was dealing with this matter so that at the earliest possible time the order downgrading the staff of the Auditor General can be revoked and proper arrangements made so that his staff will receive recognition?

Hon. Allan J. MacEachen (President of the Privy Council): Mr. Speaker, I will be happy to convey this representation to the President of the Treasury Board. I hasten to add that I was acting for the President of the Treasury Board with respect to the matter which related to the business of the House. I am not acting for him in any other respect.

**Mr. Baldwin:** I will direct my supplementary question to the Prime Minister who seemed quite interested in this matter a little while ago.

Mr. Trudeau: What do you want to ask me?

# Inquiries of the Ministry

**Mr. Thomas M. Bell (Saint John-Lancaster):** Will the Prime Minister reconsider the position of one of his ministers in this whole matter and, if necessary, ask for his resignation?

Some hon. Members: Hear, hear!

Right Hon. P. E. Trudeau (Prime Minister): As a result of this whole episode, Mr. Speaker, I certainly will advise my ministers that if there are any unanimous recommendations from standing committees over which the opposition has control, we should not automatically give implementation or credence to those recommendations from a committee which the opposition controls.

**Mr. Baldwin:** A further supplementary question, Mr. Speaker. Will the Prime Minister consider implementing the unanimous recommendation made last year by the Public Accounts Committee dealing with the Bonaventure, which the government apparently did not like?
