**Mr. Marcel Prud'homme (Parliamentary Secretary to Minister of Regional Economic Expansion):** 1. The total amount spent for NewStart programs for the following years was: 1969 to 1970, \$6,085,000; 1970 to 1971, \$5,643,000; 1971 to 1972, \$3,435,000; 1972 to 1973, \$1,800,000 (Estimate).

2. There were six projects under the Canada NewStart Program. These were located in Yarmouth, Nova Scotia; Montague, Prince Edward Island; Richibucto, New Brunswick; the Pas, Manitoba; Prince Albert, Saskatchewan; and Lac La Biche, Alberta.

INDUSTRIAL DEVELOPMENT BANK—LEGAL COUNSEL

1. What lawyer or law firm acts as legal counsel for the Industrial Development Bank in Victoria, British Columbia?

2. How much has this lawyer or law firm received in payment for services in each of the past five years?

3. Does IDB in Victoria use a legal firm to represent its interests in each mortgage they grant and, if so, are such fees included in the answer to Part 2?

4. (a) How many mortgages has the Victoria office granted in each of the past five years (b) what is the total amount of money lent through IDB in Victoria in each of the past five years?

**Hon. John N. Turner (Minister of Finance):** 1, 2 and 3. The Industrial Development Bank engages the services of outside solicitors in connection with the taking of security for its loans. However, since by statute the internal administration of the IDB is in the hands of its Board of Directors, it has not been the practice to make public the names of those who do its legal work since this is a matter relating to internal administration.

4. The IDB's statistical information is published by province and industrial classification only. During the past five years, the number and amount of loans authorized in British Columbia are as follows:
