### RECYCLING OF METALS, GLASS AND PAPER

### Question No. 3,005-Mr. Mitges:

What government departments are engaged in recycling metals, glass and paper?

Mr. John M. Reid (Parliamentary Secretary to President of the Privy Council): The Crown Assets Disposal Corporation has a contract with Florence Paper Company, Ottawa, for the removal of waste paper from some government buildings in the National Capital area. The Florence Company segregates all waste paper through a screening operation at their plant and all useable paper is delivered to companies where it is recycled.

None, however, the Department of the Environment is initiating a program for solid waste management, which will encourage and assist the development of methods to recycle valuable materials including metals, glass and paper. The Department of Energy, Mines and Resources reports research work is in progress in connection with the recycling of tin cans as feed material for steel castings.
