# DEPARTMENT OF EXTERNAL AFFAIRS—SHIPPING CONTRACTS

#### Question No. 2,518-Mr. Cossitt:

What were the names and addresses of all shipping companies used by the Department of External Affairs since January 1, 1973, for purposes of overseas shipments of any kind and, in each case (a) what were the total fees paid (b) on what basis were they selected for use by the government?

Mr. Herb Breau (Parliamentary Secretary to Secretary of State for External Affairs): Following is a table detailing the shipping companies used and total fees paid thereto by the Department of External Affairs from January 1, 1973 to April 30, 1975 for overseas shipments. With the exception of Taca International all these companies have representatives in Montreal. These companies were selected for the following reasons: (a) Service to a particular destination; (b) Availability of equipment and space; (c) Cost. - 6. What are Mr. Lord's qualifications for his present position?
- 7. Did Mr. Paul Desrosiers ever work for the Immigration Appeal Board and, if so (a) in what capacity (b) in what year (c) what was his salary?
- 8. Has any kind of security check or any other official inquiry been conducted regarding any member of the Immigration Appeal Board with respect to any such member using his position to obtain financial or other consideration from the appellants to the Board or, from their relatives?

Hon. Mitchell Sharp (President of the Privy Council): I am informed by the Immigration Appeal Board, the Solicitor General and the Department of Public Works as follows: 1. (a) Mr. Richard Lord is a Governor-in-Council appointee to the Immigration Appeal Board and is presently located at the Montreal Office of the Board. His salary is in the SX 1 range. (b) Mr. Lord has no allowances. (c) Mr. Lord was appointed for a period of two years effective September 17th, 1973.
