**Mr. Hnatyshyn:** Mr. Speaker, this is a novel point raised by the parliamentary secretary. I have not had an opportunity to consult with my colleagues as I always do with respect to these weighty issues. I was under the impression that the hon. member for Regina-Lake Centre (Mr. Benjamin) would not proceed with his bill; then I learned that he intended to proceed and unfortunately I dismissed from the chamber members of my party who had been ready to participate in the debate on this bill.

**Mr. Benjamin:** Dismissed?

Perhaps I could confer with the parliamentary secretary after I have had a chance to determine what the situation is on my side of the House.

**Mr. Knowles (Winnipeg North Centre):** Mr. Speaker, in view of the general state of flux may I suggest that we call the private member's public bill in the name of the hon. member for Regina-Lake Centre (Mr. Benjamin). If it is disposed of quickly and there is time, perhaps we could decide whether, in the time remaining before six o'clock, we should continue with debate on Bill C-13. I think there would be a general desire not to begin debating another bill between now and six o'clock. Perhaps we should first dispose of the hon. member for Regina-Lake Centre.

**Mr. McKenzie:** Mr. Speaker, I rise on a point of order.

**The Acting Speaker (Mr. Turner):** Order, please. The Parliamentary Secretary to the President of the Privy Council (Mr. Goodale) has also risen on a point of order. I shall recognize him and then recognize the hon. member for Winnipeg South Centre (Mr. McKenzie).

**Mr. Goodale:** Mr. Speaker, I rise on a point of order. It seems to me that the arrangement described by the Parliamentary Secretary to the Secretary of State (Mr. Guilbault) and mentioned by the hon. member for Winnipeg North Centre (Mr. Knowles) is sensible. I suggest that we consider item No. 37 under private members' public bills, Bill C-237 standing in the name of the hon. member for Regina-Lake Centre (Mr. Benjamin), in the hope that the bill will be dealt with expeditiously. We can hold open the option of continuing debate on Bill C-13 once we have concluded consideration of the hon. member's bill.

**Mr. McKenzie:** Mr. Speaker, I rise on a point of order. I should like to correct what the parliamentary secretary just said. He said, I think, that the hon. member for Winnipeg South Centre (Mr. McKenzie) had been speaking on behalf of the New Democratic Party. I suggest that the hon. member for Winnipeg North Centre (Mr. Knowles) spoke on behalf of the New Democratic Party, not the hon. member for Winnipeg South Centre.

**Mr. Knowles (Winnipeg North Centre):** Mr. Speaker, I was about to rise on the same point of order.

**The Acting Speaker (Mr. Turner):** Is it agreed that we consider Bill C-237 standing in the name of the hon. member for Regina-Lake Centre (Mr. Benjamin)?

### CANADIAN CITIZENSHIP ACT
