# RESPONSES TO QUESTIONS—MINISTERIAL RESPONSIBILITY

Hon. Herb Gray (Windsor West): Mr. Speaker, I want to raise a point of order about your rulings during Question Period about ministerial responsibility. I respectfully submit that the questions which you did not allow to be placed to the Minister of Regional Industrial Expansion (Mr. Stevens) were clearly phrased and intended to refer to the Minister's handling of his responsibilities concerning his Department and his administration of that Department. Second, even if the questions related to the compliance of the Minister with the conflict of interest guidelines, I submit that they were still matters of the responsibility of the Minister of Regional Industrial Expansion.

The Prime Minister (Mr. Mulroney), in the letter which has been cited often in this House, says:

I wish it to be understood clearly by all Ministers that they have an individual responsibility to prevent conflicts of interests, including those that might arise out of activities of their spouses.

It may be that the Prime Minister has delegated to the Deputy Prime Minister (Mr. Nielsen) the job of administering the process of the application of the conflict of interest guidelines, but the Prime Minister has said very clearly that the responsibility for complying with those guidelines is on the shoulder of each and every Minister.

Surely if the Prime Minister of Canada says in writing what he considers to be the responsibilities of his Ministers, then I submit with the utmost respect that it should be good enough for you, Sir.

If you accept what the Prime Minister of Canada has said, and it is clear that questions can be validly directed to Ministers about how they comply with those guidelines, I want to bring my remarks on this point to a conclusion by bringing to your attention what I think is a very important precedent.

In February, 1983 questions were directed in this House to the Hon. Marc Lalonde when he was Minister of Finance. These questions related to a matter which, as the then Opposition alleged, involved conflict of interest, which we submit was in that case unfounded—
