NEED FOR FEDERAL REGULATORY REFORM

Miss Aideen Nicholson (Trinity): Mr. Speaker, the recent takeover of the Continental Bank by foreign-owned Lloyds Bank was another signal to Canadians that the Government has not yet made good on its promise to enact comprehensive regulatory reform for the financial services industry.

The Speech from the Throne in 1984 contained a promise to follow through on the reform process begun under the previous Liberal Government. However, since then trust companies have failed, banks have closed their doors, and major financial institutions have come under the control of a non-financial institution. Studies and reports have proliferated. Provincial Governments are pursuing their own reform agendas, but our federal regulatory environment is virtually unchanged and the Speech from the Throne merely reiterated a two year old promise.

The Government is fast running out of time and options. Unless it replaces promises with action now, it will continue to be overtaken by events.
