REQUEST FOR ACCESS TO GROUNDS OF GOVERNOR GENERAL'S RESIDENCE

Mr. Jean-Robert Gauthier (Ottawa—Vanier): Mr. Speaker, I have the honour to present to the House a series of petitions, about 20 of them, asking the House in Parliament assembled to urge the National Capital Commission and the Governor General to make the grounds where the Governor General's residence is located accessible to the general public and that the decision to close access to these grounds be revoked, so that all Canadian citizens may enjoy a visit to Rideau Hall.

LOCAL MEASURED TELEPHONE CHARGES

Robinson (Burnaby): Mr. Speaker, I have the honour to table in the House a petition signed by many residents of my constituency of Burnaby who recognize the concern that the telephone pricing scheme known as local measured service, or charging for each local call, means that having a telephone will cost significantly more for most people, particularly senior citizens and the handicapped and those who rely on their telephones, such as voluntary agencies. They call upon Parliament to direct the CRTC to deny to telephone companies such as B.C. Tel, the right to charge for each telephone call and to order the retention of a monthly rental for telephones.

DECOMMISSIONING OF LIGHTHOUSE—REQUEST FOR PUBLIC INQUIRY

They are asking the Government to ensure that all retired employees keep their pension benefits and receive their unemployment insurance benefits without the deduction from pension income.

CONTINUATION OF MAIL BOX DELIVERY SERVICE TO RURAL AREAS
