THE PRIMARY SYSTEM. In his annual message to congress President Wilson recommends the application of the primary system to presidential nominations. Whether the end sought could be well achieved by a federal statute may be open to question, but the "presidential preference primary" is already established by law in many states. Indeed, public opinion everywhere is demanding that the political bosses and the machine politicians shall be shorn of their power, and that public officials shall be in fact as well as in theory elected by the people. Not one voter in fifty under our convention system is consulted or has anything to say about the selection of the party candidate. He may choose on election day between the two names printed on the official bailot, but evidently the real rulers of the country are the politicians in either party who de-
