agents discussed preliminary arrangements with the department to bring an Italian vessel to Halifax to unload squid. No further requests or approaches were made to the department and it was later learned that the vessel was directed to St. Pierre to offload its cargo. The unloading occurred sometime between October 8 and October 15, 1981. From the beginning of this transaction no refusal was given by the department and it must therefore be assumed that either the vessel owners or Zengyoren decided to use St. Pierre for freezer storage.

Toshuku Ltd.—On October 7, 1981, this company requested permission for two Korean vessels to load approximately 40 tons of squid in Halifax. This request was denied as no bilateral agreement exists between Canada and Korea.

- 2. (a) See part 1.
- (b) It is obvious from the above that little or no employment or revenue was lost due to actions by the Department of Fisheries and Oceans, nor can it be suggested that the department's decisions influenced vessels to conduct their business elsewhere as in the case of Zengyoren.

It is possible that some proposals were not completed as anticipated due to the decreased demand for freezer storage brought about by the nature and early closure of the 1981 tuna fishery.

Fisk Investment Ltd., Hugh K. Smith Investment Ltd. (b) 35978.34 square feet. (c)(i) 19897.07 square feet rented for regional customs, (ii) 6942.72 square feet rented for regional excise, (iii) 9138.55 square feet rented for port of Halifax—customs. (d) \$11.15 square foot.
