The fifth Resolution, being read a second time, and Question being put, That this House doth concur with the Committee in the 1st item of the said Resolution (\$500,000 towards the completion of the Parliament and Departmental Buildings at Ottawa),

Mr. Perrault moved, in amendment, seconded by Mr. Lajoie, that the item of \$500,000 towards the completion of the Parliament and Departmental Buildings at Ottawa, be reduced to \$300,000, this House being of opinion that \$2,500,000 having already been expended by Canada alone, for the Parliamentary and Departmental Buildings, all additional expenditure for their completion, should be made out of the revenue of the future Confederated Provinces.
