Is this added efficiency worth what it would cost? In the light of experience elsewhere, the question is not to be answered in the The thoughtful will negative. rather incline to approve of a pension plan, which places a measure of the proposed pension burden upon the recipients themselves. It is an experiment that would at least put civil service pensions to a test without involving the country in considerable expense.
