Of this amount \$80,601 was applicable to vessels loading at the port of Vancouver and the balance of \$5,585 to vessels loading at the port of Montreal. Particulars of demurrage for the following crop year, that is 1968-69, will appear in the Annual Report of The Canadian Wheat Board for that crop year when it is tabled in Parliament.

## AEROMAGNETIC PROSPECTING, ABITIBI

## Question No. 704-Mr. Laprise:

Has the federal government ceased aeromagnetic prospecting in Abitibi and, if so, when and for what reason?

Mr. R. J. Orange (Parliamentary Secretary to Minister of Energy, Mines and Resources): The aeromagnetic survey of Abitibi County was completed in 1962 mainly by the federal government. However the aeromagnetic survey for the whole of Abitibi electoral district is presently going on under a federal-provincial program. It is complete as far north as 52° north latitude and work is now being carried out between 52° and 55° north latitude.
