Hon. Ron Basford (Minister of Consumer and Corporate Affairs): I would like to tell my good friend the Leader of the Opposition that the government has not abandoned its policies to establish a prices and incomes commission. I am most anxious to have this established as quickly as possible. I have had some difficulty in the selection of personnel for the commission. I expect this difficulty will be resolved very shortly.

An hon. Member: Jim Tucker is still available!

Mr. Basford: I am delighted to hear a nomination from members of the opposition. However, under the circumstances it is one I cannot accept. I hope to make an announcement shortly. The prices and incomes commission will be part of the program of this government's determination to beat the inflation problem.

Mr. Stanfield: I have a supplementary question, Mr. Speaker. I have had bad luck with assurances today, but could the minister assure us the commission will be announced and appointed in 1969?

Mr. Basford: Yes, Mr. Speaker.

Mr. James A. McGrath (St. John's East): A supplementary question, Mr. Speaker. In view of the difficulty the minister is having in recruiting members for the commission, would he consult with the Leader of the Opposition, who will be most helpful in this regard?
