**Hon. Jean Marchand (Minister of Regional Economic Expansion):** Yes, Mr. Speaker, because when we made regulations concerning this matter, this aspect held our attention for quite a long time. It is very difficult to find businessmen who are not, at a certain time, directly or indirectly concerned with requests addressed to our department.

So, we made a regulation under which people who are directly or indirectly concerned with a request submitted to the department or one of its decisions are not to take part in the discussions of the committee, and have nothing to say concerning the decision.
