# EMERGENCY PROGRAM TO PROVIDE RAILWAY CARS TO MOVE GRAIN TO MEET EXPORT COMMITMENTS

Mr. A. P. Gleave (Saskatoon-Biggar): Mr. Speaker, I should like to direct my question to the Prime Minister. In view of statements by the Chief Commissioner of the Canadian Wheat Board that our export position is in danger and that we may not be considered reliable suppliers because of the transportation situation, can the Prime Minister tell the House whether the minister or the Department of Transport has in hand an emergency program to supply the necessary transportation to move our grain to export?

Right Hon. P. E. Trudeau (Prime Minister): As I tried to indicate in my previous answers, Mr. Speaker, the minister is bringing forth to cabinet certain proposals relating to railway cars, and I indicated that this would be announced in the proper way.

Mr. Gleave: In view of the fact the statement by the Minister of Transport did not really deal comprehensively with this matter, may we have some assurance that the minister will at an early date make a statement on motions indicating how he or his department is going to deal with this emergency situation?

Mr. Trudeau: Mr. Speaker, the minister dealt at some length with this matter just a few days ago. If the hon. member wants him to deal with other aspects I am sure there will be many other occasions to do so—at the time of consideration of his estimates, on opposition days, or at the time of the minister's own action or announcements in the days and weeks to come.

Mr. Speaker: Order, please. The Chair will recognize the hon. member for St. John's East for a last supplementary question on this subject in view of the fact that we are still on the first round of questions. Following that, the Chair will see the hon. member for Cape Breton-The Sydneys.

# STUDY BY TRANSPORT COMMISSION OF GROUND TRANSPORTATION IN NEWFOUNDLAND
