subsequently withdrew his bid. This contract was placed on behalf of the Department of Indian Affairs and Northern Development.

*NATIONAL DEFENCE—ORDERS AND BADGES

Question No. 2.403-Mr. Forrestall:

Will the Minister of National Defence give consideration to personally reviewing the orders that went to members of the Canadian Armed Forces to the effect, that members who were previously authorized to retain their pre-unification rank designation and who concurrently retained their pre-unification element/service badges are now to be required to wear badges representing the occupational classification while concurrently being permitted to retain their pre-unification rank designation and, if not, for what reason?

Hon. James Richardson (Minister of National Defence): Mr. Speaker, the answer is as follows: 1. Dress instructions issued on April 3, 1970, stated that the cap badge associated with the class of service to which officers and men are assigned, was to be worn when the badge became available.

- 2. Cap badges in general use at that time were authorized to continue to be worn during the intervening period.
- 3. During this intervening period that is from April, 1970 to the present time extensive discussions with personnel at all levels were held and, cap badges in some cases were designed, and in all cases were approved by all groups concerned.
- 4. There is every indication that servicemen and women wish to be identified with the particular type of military duty in which they are engaged, and that the new cap badges are being worn with pride.
