might be entitled to receive legal aid but that it would be necessary for the member to contact the legal officer directly. The legal officer also explained that if she urgently required legal advice, she should contact a civilian lawyer, at which time she indicated she already had done so.

10. Regarding instituting an investigation this has already begun. Sergeant Hutchison has instituted "redress of grievance" procedure within this department, and this automatically causes an investigation to be carried out.

11. The policy of the RCMP is to maintain the confidentiality of names of people they contact during the course of their inquiries. This policy extends to identifying members of the RCMP, the purpose and length of any ensuing discussion.

We now realize that perhaps the 489.99 D.M. could have been converted to Canadian dollar value and the bill paid in Canadian currency on the converted amount. A refund claim would be in order.
 - (d) Yes. As follows—one pair of headphones and \$33.98 in lieu of D.M. 33.98 (same explanation as in (c) above).
 - (e) No members of staff of the Canadian Embassy in Prague recall a conversation with Sergeant Hutchison on Canadian Customs regulations. However, a copy of Revenue Canada's booklet "Moving Back to Canada" received by the Embassy from the Department of External Affairs on January 7, 1980, was circulated to all Canada-based staff including Sergeant Hutchison, who initialled the covering form as having seen this document. The booklet states in part "if you have been residing outside Canada for anything from the one-year minimum to just under five years, your personal and household effects must have been in your ownership, possession and use for at least six months before you re-enter Canada".

FUNDING OF CANCER RESEARCH

Question No. 1,572-Mr. Howie:

What amount of government funds has been allocated for research into the causes and treatments of cancer?

Mr. Doug Frith (Parliamentary Secretary to Minister of National Health and Welfare): In so far as the Department of National Health and Welfare is concerned: funds allocated for research into causes and treatment of cancer during the fiscal year 1980-81 amount to \$2,630,140. This sum excludes salaries of professionals conducting intramural research.

In so far as the Medical Research Council is concerned: to date, for the fiscal year 1980-81, \$5,100,000 has been committed to research and research training to causes and treatment of cancer.
