MR. SKELLY—TELEVISION PROGRAMMING POLICY

Mr. Ray Skelly (Comox-Powell River): Madam Speaker, today I have the honour to present a petition to the House from the residents of Port Hardy, British Columbia, comprising some 40 pages of signatures, outlining a very serious problem resulting from the Government's removal of access to television programming choice in the Port Hardy area. It is an indication that the Government has discriminated against rural communities in terms of many leisure time activities.

In their petition, the people of Port Hardy wish to point out, and ask for relief from, rulings of the CRTC and policies of the Government which would prohibit their access to programming of their choice, and they ask that the quality of television and radio communications in the northern part of Vancouver Island be improved in general.
