Right Hon. Brian Mulroney (Prime Minister): Mr. Speaker, I would of course have to examine the circumstances of the statement you just quoted. It should be placed into its context.

But I can say, as I told my friend for Granby, that the fact that the Caisse or the Société générale de financement owns shares is important as a matter of fact, strictly because the connection leads us to the Quebec Government. It is important in such a transaction that we should be able to speak with those who take the decisions. That is all.

Mr. Cassidy: Mr. Speaker, would the Prime Minister know whether the ideological biases of Bay Street, as voiced by his Minister of Regional Industrial Expansion, are to set government policy and whether the Government will be concerned about the true economic needs of Quebecers?

Mr. Mulroney: Mr. Speaker, I can tell you that the only Quebecer who is biased in favour of Bay Street interests is the Hon. Member for Shawinigan, who represents them.
