The parliamentary secretary also referred to discussions which occurred between the parties early this week and he seems to have forgotten the actual course of events.

Mrs. Finestone: Maybe he distorted them.

Mrs. Catterall: I would not suggest, as my colleague behind me did, that he might have distorted them. I would not say that for a moment. He has been in the House of Commons since at least 1978, so perhaps it is just that his memory is failing somewhat since Monday and Tuesday.

He accused my colleague, the member for Dartmouth, of being responsible for not achieving wage parity for the ships' crews workers. I want to remind the member opposite and I want to make sure that this is clearly on the record, that in fact it is the member for Dartmouth who, earlier this week, was able to get a commitment from the President of the Treasury Board that parity for east and west coast workers would be effective the date an agreement was signed; that it would not be something that needed to be negotiated at the bargaining table. I will have more to say about those discussions later.

An Hon. Member: Time.

Mrs. Catterall: I have no intention of concluding before 1.16 p.m., so we are into a continuing situation here, Mr. Speaker.

Mrs. Finestone: It is up to the Chair to call it.

Mrs. Catterall: The member for Dartmouth has admirably represented his constituents. We will—
