Mr. D. M. Fisher (Port Arthur): Mr. Speaker, I want to ask the Minister of Trade and Commerce a question, one which I would have placed on the order paper but I was informed that it would be better put on orders of the day. The question is in relation to the advertising contract which the McLaren's advertising agency holds with the Department of Trade and Commerce. I want to ask the minister whether there is any agreement, verbal or written, that McLaren's advertising agency will provide other services than those which are going to the government, say to the Liberal party, as a result of this contract.

Mr. Speaker: Order. I regret to say that I think this question is out of order on several grounds. First, it should relate to public affairs and the hon. member is asking a question relating, if you wish, to private party matters. Second, he is making an allegation, or a statement, or an assertion. Therefore I would suggest that if he wishes to ask this question he submit it to me in writing so that it can be carefully considered to see whether or not it is in order.

Mr. Fisher: The question as I understood it, Mr. Speaker, was referred to you, but I should just like to say this. You said that this question concerned a private affair. If there is any understanding regarding a public contract which carries over into the private field, if political party management is a private field, then I would say that this is very much a question for the public and for this house. However, I will accept your suggestion.

Hon. Mitchell Sharp (Minister of Trade and Commerce): Mr. Speaker, could I be permitted to answer this question. If the question is in order—and I am not suggesting it is—the answer is no.

REQUEST FOR INCREASED ADVANCE PAYMENTS
ON FARM STORED GRAIN
