REPORTED MEETING BETWEEN BRITISH COLUMBIA AND ALASKA

Has the minister's attention been drawn to a meeting between representatives of the government of British Columbia and representatives of the state of Alaska with respect to the joint development of two large hydroelectric projects in our north?
