When I asked the hearings concerning the C.N.R. run-through Minister yesterday about the possibility of the Fair Wages and Hours of Labour Act being amended by July 1 so that federal employees covered by it would have the same conditions other employees have under the Canada Labour Code, he told me he was shy about giving me a deadline and that he did not intend to let me beguile him. I wonder whether the Minister is aware of the fact that on February 26, when I asked him whether these people would be covered by July 1-those who are federal employees-in the same way as those who come under the Canada Labour Code, his reply was "That is the intention." Will the Minister confirm that intention now?

Hon. A. J. MacEachen (Minister of Labour): Well, Mr. Speaker, it was stated at the time the Canada Labour Code was debated that it was the intention of the Government to apply the same principle to its own employees, and that is still the intention.

Mr. Knowles: But will this be done by July 1?

Mr. MacEachen: That is the intention, Mr. Speaker.

Mr. Georges Valade (St. Mary): Mr. Speaker, I have a question for the Prime Minister which concerns the three points of privilege stated yesterday by Members of this House on the Government side, namely the hon. Member for St. Lawrence-St. George (Mr. Turner), the hon. Member for Notre Dame de Grâce (Mr. Asselin) and the hon. Member for Lafontaine (Mr. Lachance). In view of the questions of privilege which were raised, which will very seriously endanger the reputation of the House and the Party in power, I am wondering whether the Prime Minister will consider referring the whole matter to a special investigating committee. as was done with the N.D.P. accusations of electoral fraud, and whether he would not consider taking this step so as to justify his own Members and clear this House from any bad reflections this matter could have.
