## GRAIN

WHEAT—PRICES PAID FOR SHIPMENTS TO INDIA

On the orders of the day:

Mr. Grant Deachman (Vancouver Quadra): Mr. Speaker, I have a question for the Minister of Finance. Can the minister inform the house whether the federal government has recently purchased wheat for India from the private trade at a premium over wheat board prices?

Hon. Mitchell Sharp (Minister of Finance): Mr. Speaker, the hon. member is probably referring to an article that appeared in the Globe and Mail on January 19 in which such a suggestion was made. I should like to make it quite clear that the government has purchased wheat for India for shipment from both the Atlantic and Pacific coasts. This wheat was purchased from the private grain trade at prevailing prices. There was no premium involved. The government in effect paid prices comparable to those which any other buyer in the world would have had to pay for Canadian wheat at the time the purchase was made.

Right Hon. J. G. Diefenbaker (Leader of the Opposition): Mr. Speaker, with reference to the reply given a few moments ago by the Minister of Finance, would he advise the house what price was paid to the grain trade for No. 2 Northern wheat and also for No. 3 Northern?

Mr. Sharp: Mr. Speaker, this is the sort of question that might better be put on the order paper; but in view of the fact that I did make reference to this matter today, I can give the right hon. gentleman some examples. There were several cargoes. With respect to shipment from West St. John, the price of grade No. 2 was \$2.137 per bushel. The estimated replacement price would be exactly the same. From the same port, for No. 3 northern the price was \$2.05% and the estimated replacement price was \$2.04%. From Pacific ports, No. 2 northern, the price was approximately \$2 and a very small fraction of a cent while the replacement price was the same. Those are examples.

Mr. Diefenbaker: What about No. 3 northern in Vancouver?

Mr. Sharp: There were no transactions in No. 3 northern from Vancouver.
