CMHC—LOANS TO HOME OWNERS IN ISOLATED AND SPECIAL AREAS

## Question No. 502-Mr. Hopkins:

Will the present CMHC practice of granting loans to home owners in larger towns and cities in isolated areas of Canada be expanded in 1971 to include towns and cities in special areas as designated by the government?

Hon. Robert K. Andras (Minister without Portfolio): In 1971, direct lending by Central Mortgage and Housing Corporation under the National Housing Act will continue to be directed, as in 1970, toward increasing the volume of housing available to low and modest income families throughout Canada. Central Mortgage and Housing Corporation, in its direct lending will also endeavour to meet the most urgent housing needs, which have usually occurred in new resource towns and in smaller cities and rural areas throughout the country, arising from an inadequate distribution of loans by the institutional lenders. It is anticipated, however, that an increased volume of lending by lending institutions will decrease lending by Central Mortgage and Housing Corporation in some of the smaller towns and rural areas in 1971.

# PUBLIC SERVICE EMPLOYMENT ACT

Yes, except where otherwise provided for under the following sections of the Public Service Employment Act: (i) The Governor in Council has full authority under sections 32(6)(a), 34(1), 38 and 44. (ii) The Governor in Council has authority under sections 35 and 39 provided a recommendation is made by the Commission. (iii) A Minister has authority to appoint his Executive Assistant and other persons required in his office under section 37(1). (iv) The Deputy Minister has authority under sections 26, 27, 28(2) and (3), and 29(1).

HOLDINGS OF CANADA SAVINGS BONDS IN 1969

### Question No. 534-Mr. Godin:

1. During 1969, what was the amount of Canada Savings Bonds held by individuals in Canada?

2. What rate of interest is paid to them?

Hon. E. J. Benson (Minister of Finance): 1. At December 31, 1969, the amount of Canada Savings Bonds outstanding was \$6,683 million of which more than 99 per cent were owned by individuals and estates, the remainder being held by associations, corporations and charitable organizations.

2. Rates paid on Canada Savings Bonds outstanding vary according to the issue held, and for certain of the issues, interest coupons are payable at various rates. The terms of all CSB issues outstanding may be found in the publication, Loans of Government of Canada and Loans Guaranteed by the Government of Canada.
