STATUS OF DESTROYER CONSTRUCTION PROGRAM—ADDITIONAL COST

Mr. Thomas M. Bell (Saint John-Lancaster): I have a question for the Minister of National Defence. Can he say whether the destroyer construction program—I refer to the St. Laurent class—is on schedule and whether the companies involved have asked for any extras?

Hon. Donald S. Macdonald (Minister of National Defence): I regret to say that there has been a slippage of approximately one year in the timing of the program. An analysis is under way at the moment to determine to what extent this will affect the delivery dates and the availability of the ships for service. It will also indicate, since time is money, how much additional cost the treasury will be exposed to if the program is to go ahead in the form planned.

Mr. Bell: I have a supplementary question, Mr. Speaker. As the minister starts work in his new portfolio will he give every assurance, in view of rumours that the leakage of money may be upward of \$20 million, that he will not allow another *Bonaventure* fiasco to take place as did one of his colleagues sitting in the front row not far from him?

SYDNEY, N.S.—SUSPENSION OF ADULT STU-DENTS BY INSTRUCTOR FOR MAKING REPRE-SENTATIONS CONCERNING ALLOWANCES

Mr. Robert Muir (Cape Breton-The Sydneys): I have a question for the Minister of Manpower and Immigration with reference to a wire forwarded to him from the Nova Scotia Minister of Labour protesting the suspension of 18 adult students by an instructor of adult training in Sydney, Nova Scotia, because they have made representations about training allowances which have been withheld. Would the minister have an investigation carried out to determine why these men and women have been suspended and immediately have them reinstated without any loss of benefit?
