OBJECTION TO REPORT OF COMMISSION FOR THE PROVINCE OF QUEBEC

Madam Speaker: It is my duty to inform the House that an objection signed by the Hon. Members for Nunatsiak (Mr. Ittinuar), Moncton (Mr. McCauley), Welland (Mr. Parent), Notre-Dame-de-Grâce-Lachine East (Mr. Allmand), Ottawa-Vanier (Mr. Gauthier), Ottawa-Centre (Mr. Evans), Hamilton West (Mr. Hudecki), Etobicoke North (Mr. MacLaren), Abitibi (Mr. Gingras) and Winnipeg-Fort Garry (Mr. Axworthy) has been filed with me pursuant to Section 20 of the Electoral Boundaries Readjustment Act, Chapter E-2, R.S.C. 1970, to the Report of the Electoral Boundaries Commission for the Province of Quebec.

MRS. HERVIEUX-PAYETTE—ELIMINATION OF LEAD ADDITIVES TO GASOLINE

Mrs. Céline Hervieux-Payette (Montreal-Mercier): Madam Speaker, I have the honour to present to the Honourable House of Commons of Canada, in Parliament assembled, the petition of the undersigned residents of the Municipality of Baie Comeau in the Province of Quebec, who now avail themselves of their ancient and undoubted right thus to present the following grievance: That the practice of adding lead to gasoline is the main cause of high levels of lead in the atmosphere.

That it is a recognized fact that exposure to even minimal quantities of lead is dangerous to human health, and especially to children and the unborn, since it can affect the development of the brain and the child's mental capacity, and can cause behavioral disorders.

Therefore your petitioners humbly pray the Government of Canada will enact legislation that will put an end to the practice of adding lead to gasoline in Canada and provide that existing alternative solutions will be used.
