## **FISHERIES**

#### EXCLUSION OF FISHERMEN FROM VANCOUVER DOCK

Mr. Ted Miller (Nanaimo-Alberni): Mr. Speaker, my question is directed to the Minister of Fisheries and Oceans. He is aware that some 60 fishermen have been excluded from a traditional fish dock in False Creek in Vancouver, because the Minister's Department has signed a private contract for a wharf for fishermen who have wharf-side sales. Would the Minister inform the House at what stage are negotiations for making other space available for those displaced fishermen who have very little opportunity in the Vancouver area of finding additional space for their vessels?

Hon. Pierre De Bané (Minister of Fisheries and Oceans): Mr. Speaker, I approved that initiative in view of the support that it has received in the last few months not only from the municipal authorities but also from several members of the Minister's advisory council. That initiative would help the commercial fishermen sell their catch to the general public.

I hope that this initiative will be well received by the public and provide an excellent opportunity for fishermen to engage in direct sales and thus enjoy a higher profit while selling ocean fresh fish products at attractive prices.

Depending on the success of this initiative, we might study other similar ventures that could be authorized in the future.
