"33.1 Nothing in Part IV and no regulations made by the Governor in Council pursuant to Section 32 or Section 33 shall abrogate or derogate from the provisions of the Canadian Charter of Rights and Freedoms, and, in particular, the provisions of Part IV or regulations made under Part IV shall be read or construed not to abrogate or derogate from the requirement of significant demand, significant demand being the number of persons who are in the linguistic minority in the area in respect of an official language spoken as a mother tongue is at least fifteen (15) percent of the total number of persons residing in the area."
