In a second carriage were Premier Waldeck-Rousseau and others. Along the entire route the president was greeted with cries of "Vive Loubet!" and "Vive la republique!" When he arrived at Langchamps the shouts were redoubled. Gen. Kermartin handed over the command of the troops to Gen. Brugere, the military governor of Paris, and the review began forthwith.

LIONIZED MARCHAND.

Gen. Brugere galloped along the front of the line, and the distribution of decorations followed. Then the general took up a position in front of the presidential stand and as each regiment passed its flag was dipped and the president rose and saluted the Each time he was greeted cheering for the army.

Suddenly a roar of applause ascended from the distant masses of spectators and increased in volume as Major Marchand, the African explorer, and principal figure on the French side in the Fashoda incident, mounted on a superb black charger, and surrounded by the Soudanese soldiers who had accompanied him across the African continent, appeared in view, and, amidst increasing excitement, defiled in front of the president. The air rang with deafening cries of "Vive Marchand!" and "Vive l'armee!" and hats and handkerchiefs were thrown up on all sides. As President Loubet arose the cheers were redoubled, and continued until the little band of Soudanese disappeared in the distance. The review was concluded at 4:20 pm

CAPE PARLIAMENT OPENED. Cape Town, July 15 .- The Parliament of Cape Colony was opened yesterday. A large crowd of people assembled outside the parliament building and hailed the arrival of Sir Alfred Milner, the British high commissioner and governor of Cape Colony, with deafening cheers, after which "God Save the Queen" was sung twice by the people. AN "OBJECT LESSON"

Peculiar Street Railway Situation in the City of the Straits.

Detroit, Mich., July 14 .- "Three cent fares" are announced today on the fronts of Detroit street cars in the places where amusement advertising signs are usually carried. This sudden voluntary reduction is the result of a decision of Governor Pingree and Tom L. Johnson to give the people an object lesson upon what they may look forward to. If present plans for the sale of all the Detroit street railways to the Detroit Municipal Railway Company, in behalf of the city. succeeds. The three-cent tickets sold today at five for 15 cents are so worded that their use in full payment of fare can be withdrawn at any time. The city is in a furore over the present situation. All the newspapers and nearly all the more prominent citizens are opposing the Pingree plan, and it is now claimed that the majority of citizens oppose it. on the

ground that three-cent fares and quasi-municipal ownership will fail to pay the expenses and the \$17,000.000 proposed to be paid for the roads, and that they will, if purchased, revert to the present owners. In the latter event, the road would be operated under the security ordinance already passed by the council, which permits the operation of all the roads at a six for a quarter fares for from 30 to 48 years. The Pingree people claim that the road will certainly pay off their purchase price under three cent

Governor Pingree is having circulars distributed on the streets giving his side of the controversy.

A special meeting of the city council is called for this afternoon, at which a "working ordinance" is expected to be passed, granting the municipal company rights as to operations of the roads. This ordinance reserves to the city the right at any time to fix the rates of fare, said rate meanwhile to be three cents with universal transfer. Mayor Maybury will veto both ordinances, and the question is whether the Pingree people can secure passage of both over the

ENCOURAGING TRADE OUTLOOK

Crop Prospects Improved by Rain-Wholesale Trade in Toronto More Active Than for Years.

New York, July 15 .- R. G. Dun & Co.'s weekly review says: The Canadian dispatches show no change of consequence in the course of business. At St. John wholesale business has declined, but retail trade keeps up well and collections are rather better. At Quebec business is fairly good, with collections average. Montreal reports that rains have improved crop prospects, and the make of butter and cheese is large, with general business and collections good for the season. Wholesale trade at Toronto is more

active than for years, with crop pros-pects bright and feeling among merchants never so hopeful. Manufacturing is especially brisk at Hamilton, with wholesale groceries fair to active, but most retail lines are quiet. Trade is fair at Winnipeg, with encouraging prospects, and at Vancouver wholesale trade is satisfactory, though less active at retail in staple lines. Salmon canning operations on the Fraser have commenced under favorable conditions. Wholesale business at Victoria is rather quiet, and also retail, with collections firm.

Bradstreet's says: Crop conditions in Canada resemble those in the United States in several respects. The yield of wheat in Manitoba promises to be 10 per cent in excess of a year ago, while that of Ontario winter wheat will be slightly smaller, but crops throughout Quebec are in exceptionally good condition, except as to hay, the yield of which will be smaller. Toronto re-ports fall trade in full swing, with values firm. Efforts to get the leading wholesale grocers to join a syndicate is reported. That is of interest. because the grocers now have an agreement with Canadian refiners not to sell American sugar. Some speculative buying of wool is reported at Toronto. hopes being expressed of expanding. United States demand furnishing a market for this product. Montreal reports advances in prices of paints, oil and glass, flour in good domestic and export demand, and general business fully up to the average. the Maritime Pros dull, while in British Columbia more activity is reported and exports are heavy but collections still slow. Business failures in the Dominion of Canada number 27, as compared with 25 last week, and 28 in this week a

R. G. Dun & Co.'s review says: Because every prospect pleases, it is the right time to watch most closely for signs of trouble. It is not easy to find them when the volume of business is 63.7 per cent larger than last year and 75.5 larger than in 1892, the best of all years, except the last, or when failures continue to be the smallest ever known, or when railroad business is by far the best ever known, or when New York bankers appear in international operations, listening to a Russian inquiry and undertaking a Mexican loan. industrial disputes incident to the season cause less trouble than usual. The largest shipments of boots and shoes in any year for the season -193,080 cases in two weeks, greater by 17.4 per cent than last year, 8.6 per cent than in 1897, and 29.4 per cent than in 1892—result very extensive pressure to anticipate orders for August and September, distribution far exceeding expec-tations. Though cotton is steady, in spite of Texas floods, at 6.19 cents, and the general demand for cotton goods is full and sustains prices, a reduction of half a cent in some fancy prints is reported. Larger distribu-tion is expected this month, and ex-port demand increases. In wool a great speculation is in progress, sales in two weeks reching 22,261,100 pounds, against 24,572,800 in 1897, when the buying was to anticipate new duties. Failures for the week have been 169 in the United States, against 215 last year, and 24 in Canada, against 33 last year.

SCOTTEN'S ESTATE

Court Has Released the \$900,000 Tied Up-Heirs and Government Reach an Agreement.

Windsor, July 15.-In the surrogate court yesterday, before Judge Horne, Attorneys J. H. Rodd, for the Scotten estate, and R. F. Sutherland, for the Ontario Government, reached an agreement by which the \$900,000 belonging to the estate, which has been tied up in the Canadian banks for several

months, will be released. When papers of administration in connection with Scotten's Canadian estate were applied for last April by E. O. Fleming, of Windsor, the Ontario treasury department, through Attorney Sutherland, opposed the application, on the ground that a large amount of money deposited in Canadian banks by the late Daniel Scotten, of Detroit, just after he had disposed of his tobacco business, was not included in the inventory of the estate filed with the probate judge. The de-partment claimed that the money should thave been included and suc-

cession duties paid on it. The estate admitted that \$900,000 was on deposit in the banks at Windsor,

London, Hamilton and Toronto, but claimed that the money had been placed there merely for safe keeping, not for purposes of investment, and was not liable for the succession tax.

On a quiet summer evening, The case has been pending ever since. By the arrangement reached, estate agrees to deposit in a char-tered bank in Toronto \$50,000, to the joint credit of Provincial Treasurer Harcourt and Z. A. Lash, the Toronto solicitor for the estate, out of

which the succession duties, estimated at \$45,000, will be paid if it is afterward determined that the money is liable for the tax. A further sum of \$10,000 will also be deposited to the credit of the same parties to pay additional tax on the real and personal property of the estate, if it is found that they have been undervalued. The government agrees to allow the papers of administration to be issued and the question of the liability of the \$900,000 for succession duties will be submitted to the courts.

AN HOUR OF AGONY

Sickening Execution of Walla Tonaka at Alikichi, I. T.

Alikichi, I. T., July 15.—Wm. Goings, otherwise "Walla Tonaka," was shot yesterday under sentence of the Choctaw court, for murder. An attempt to stop the execution by a writ of habeas corpus failed, the Indian sheriff refusing to honor the document. The execution was a sickening sight. Goings was made to kneel on a quilt before his coffin. The sheriff bared his bosom painted a spot over his heart, stepped back four paces rested a rifle across a bench and fired. The bullet entered the breast, but missed the spot. Goings fell backward and moaned for an hour before expiring. Water was poured down his throat a number of times to hasten death by strangulation. CATACOMBS OF ST. MARY'S

A Strange Burial Place in the Heart of London.

[From the London Telegraph.]

How many people in London are aware of the catacombs of St. Marys? Despite the bustle and roar incidental to the biggest railway station in England-Liverpool street station is on the opposite side of the road-the visitor to St. Marys can, by a little stretch of the imagination, picture himself in one of those strange burial places of the early Christians, which may be found on either side of the historic Appian Way. Here lie the bodies of hundreds of the "faithful departed," the coffins hermetically sealed in a fashion which would satisfy the prejudices of even the most scrupulous sanitary inspect-The place is not open to public ors. view, but, thanks to the courtesy of Father Fleming, our representative was allowed to tread his way, with the assistance of a lighted taper, amid the crumbling remains of former parishioners of St. Marys. No inscriptions are visible, but each coffin is duly not-ed in the register of the church. Some Hustrious personages are buried im-mediately beneath the high altar-Bishops Poynter, Bramstone and Gradwell, for example. There is ample space for several more, but modern authorities are not partial to burials in the heart of the city. Close by the bishops, in a number of coffins piled in regular tiers, are the remains upward of 30 priests, who served the church well in their life and now find a congenial resting place beneath the very altar where they celebrated the mysteries of their ancient faith. It was the dearest wish of Cardinal Wiseman to have his body interred within the sanctuary of St. Marys, but the law intervened, and a white ble slab with a modest epitaph composed by himself when in the full vigor of health now indicates the place where he would have gladly rested. Strolling about this strange cemetery, situated in one of the most densely populated quarters of London, it was a somewhat weird experience to hear street cries, and, peering above the through ventilation holes, see continuous lines of 'buses and cabs the adjoining thoroughfare.

Among the notabilities in the cata-combs we find "Honest Jack Lawless," doughty follower of O'Connor, the liberator, and many other personages who held a large share of public attention in their day. Weber, the celebrated composer, who, strangely enough, was made a count "after his death," and buried here, but some years later his remains were removed to Dresden. In the small strip of ground adjoining the church, as well as in the vaults. no less than 5,500 Catholics were buried prior to the year 1853. When the church is demolished it is probable that every body will have to be remooved, although where so huge a collection of dead humanity will ultimately rest does not yet appear to be decided. There is an instance on record in the city where simflar removals were undertaken at £10 per head. It is obvious that so costly an outlay would be impossible in the present case, Though dead, many of the persons buried at St. Marys, Moorfields, are not forgotten, and the prospect of an approaching removal of remains will result, it is anticipated, in a deluge of correspondence from rela-
