And they ended their note with:

(Translation):

We are making this correction even before being requested to do so by Hon. Mr. Claxton, because it is a matter of justice.

(Text):

As it happens, I have the text of the speech referred to, as delivered in French and English. What I said in English was:

In its proposals to the provinces, the dominion government has tried to put the provinces in a position where they could properly discharge their constitutional responsibilities. It is not contribution for the sibilities. It is not centralization for the federal government to offer to pay Quebec \$57 million for what was never before worth to the province more than \$31 million. The dominion is trying to avoid double taxation and treat all Canada on an equal basis so as to enable every part to develop its resources and discharge its responsibilities for the education and well-being of the people.

A French translation was given to the press at the same time. It will be seen from the foregoing that what I said was actually-

Some hon. MEMBERS: Order.

Mr. CLAXTON: -almost exactly the reverse of what the hon. member for Beauharnois-Laprairie quoted me as saying.

Mr. FERGUSON: I submit that in making a speech at this stage the minister is out of

Some hon. MEMBERS: Order.

Mr. FERGUSON: I am tired of listening to that.

CLAXTON: I am sure that like L'Action Catholique the hon, member for Beauharnois-Laprarie will be the first to regret the error made.

MR. DROPE-FLOOR PRICE ON BUTTER

Mr. R. E. DROPE (Northumberland, Opt.): The hon. member for Victoria, B.C., (Mr. Mayhew) is reported on page 3127 of Hansard as saying that in my speech of May 8, I asked for a subsidy on butter. I wish to correct the hon, member and I refer him to page 2892 of Hansard. What I said was: If the ceiling price and rationing are to be continued, a floor price should be put on butter.

REQUEST FOR AMENDMENT OF OLD AGE PENSIONS ACT

Mr. M. J. COLDWELL (Rosetown-Biggar): Mr. Speaker, I desire to present and endorse a petition signed by Mr. John Beckett and 256,282 others. It is very short, and I would therefore ask permission to read it to the house

Mr. COLDWELL: It reads:

To the Honourable the House of Commons of Canada in Parliament assembled:

The petition of the undersigned citizens of the Dominion of Canada humbly sheweth:

That, in the opinion of your petitioners, the present standard of old age pensions is grossly inadequate to provide a life of security and dignity to the aged people of this dominion.

Wherefore your petitioners humbly pray that your honourable house may be pleased, during the present session of parliament, to amend the Old Age Pensions Act

(a) to provide pensions of not less than fifty dollars per month at age of sixty-five,

(b) to eliminate the means test

(c) to provide, in addition to the basic pension, a cost of living supplement, invalidity supplement, and free medical, dental, optical and hospital care, and

(d) to provide that all such pensions be paid

in full from the dominion treasury

And as in duty bound your petitioners will ever pray.
