C. P. R. AID TO IMMIGRATION WILL BE FREELY BESTOWED

At the Farmers' and Dairymen's
convention this morning, Mr. Allan
B. Willmot, the Superintendent of Im-
migration for the Province, read a
most instructive paper on Immigra-
tion Problems, which will appear in
The Gleaner tomorrow.

Mr. H. P. Timmerman.

Mr. H. P. Timmerman, the indus-
trial commissioner of the C. P. R., ex-
pressed the interest which his com-
pany was taking in the development
of the province. The importance of
the agricultural industry in the pro-
vince could not be over-estimated,
and it was one in which railways
were intimately concerned. In the
matter of immigration the railways
could very materially assist in this de-
velopment, and the C. P. R. recog-
nized this and had recently inaugu-
rated an industrial branch to carry on
this work. There were great oppor-
tunities before them, and they should
be properly valued. These opportu-
nities had been sadly neglected in
the past but as far as the C. P. R.
was concerned that corporation would
do its utmost to enhance the wel-
fare of the province in the future.

Mr. Geo. H. Ham.

Mr. Geo. H. Ham congratulated the
Provincial Government upon the in-
auguration of an immigration policy,
and also the Salvation Army which
was doing such good work. For the
C. P. R. he could say that they would
gladly co-operate in the work. The
company would only be too glad to
assist in repopulating New Brun-
swick. There were, he understood,
some 50,000 acres of Crown lands in
this province, and as far as he (the
speaker) was concerned, he would do
what he could to settle these lands.

Mr. C. A. Duff Miller.

Mr. C. A. Duff Miller, the Agent
General for this province in England,
was then called on, and expressed his
gratification at finding the present
government realized the pressing
needs of the province. He said they
had in England any number of men
and women who would make suitable
citizens of this province, if the ad-
vantages which it had to offer were
only put before them. He was pleas-

ed to think that there was now an
opportunity of this being done. The
immigration-agency in this province
would be of enormous benefit in plac-
ing settlers. He looked for the rapid
expansion of this province.

Mr. F. L. Fuller.

Mr. F. L. Fuller, the superintendent
of Nova Scotia Agricultural Societies,
then addressed the meeting on the
subject of Agricultural Societies, and
in the course of his remarks said that
the prime factor for success was pro-
per organization, and he instanced
the rapid strides made by Denmark
as an agricultural country, owing en-
tirely to organization.

The speaker gave very interesting
accounts of methods adopted by the
government of Nova Scotia to further
the interests of agriculture, from
which it was apparent that very much
more was being done by that pro-
vince than was the case in New Brun-
swick.

THE RIVAL GRAND FALLS COMPANIES

Representatives of Companies
Declare That Each is Pre-
pared to Rush Develop-
ment at Once.

The Provincial Government yester-
day afternoon heard the presentation
of the cases of the rival interests
seeking permanent control of the
Grand Falls water power, and a de-
cision to harness it for commercial pur-
poses. Mr. H. A. Powell, K. C., as
counsel, and Mr. C. F. Sanford, of
Barnhill, Ewing & Sanford, St. John,
as attorney, and Mr. McCrae, expert
engineer of Ottawa, and Messrs.
Henry McLaughlin and A. L. Shaw,
of New York, appeared on behalf of
the Grand Falls Water Power Co.
This is the last company incorporat-
ed, and in 1905 upon depositing \$50-
000 as a proof of their bona fide in-
tentions as an enterprise secured the
lease of the water power privileges,
and in 1907 this lease was amended.
Mr. H. H. McLean, M. P., and Mr.
F. R. Taylor appeared for the old
company, which was formed by Sir
William Van Horne, of the C. P. R.,
and the late Senator Proctor, of Ver-
mont, with other interests. This com-
pany had charter rights which ex-
pired before anything in the line of
definitive development work had been
done, and the other company then
came in and upon putting up a de-
posit of \$50,000 were granted the
rights by the late Government in
1905.

The immediate cause of the ap-
pearance of the representatives of the
companies was the application by the
new company for the Government to
take steps in carrying out the legis-
lation of 1907, looking to the exprop-
riation of the land held at Grand
Falls by the Van Horne-Proctor in-
terests and to fix the amount of bond
which would be necessary for the
company to put up in the event of
the expropriation proceedings being
commenced. The land which the new
company is to expropriate is held by
the old company and is situated just
above Grand Falls at a crucial point.

The Government heard the argu-
ment of both sides, and each declared
the intention of proceeding at once,
to the active work of development if
given the opportunity. The new com-
pany claimed to have already spent
upwards of \$60,000 in surveys, borings
and other development work, and
stated that they had already awarded
contracts for the erection of their
plant, and the installation of the
necessary machinery.

The Government promised to give
both sides of the case careful con-
sideration, and will later announce their
decision.

Dominion Coal Showed Im-
provement on Montreal Ex-
change—The Quotations
on Wall Street.

Montreal, March 18.—Strength was
the characteristic of most of the
stock trading to-day. Soe sold up to
146 and Dominion Coal also reflected
the improved outlook, selling up to
69 1/2. Other features were Pacific,
167 7/8; Quebec, 50 1/4; Asbestos, 92
3/4; Textile, 65 to 64 1/2; pfd. 100; Do-
minion Steel, 32 3/8, pfd. 113; Power,
was an easier feature at 110.

On Wall Street.

New York, March 18.—Small de-
clines were the rule in the opening
quotations for stocks, but there was
a sprinkling of gains, of which the
most prominent was Union Pacific,
with a rise of a quarter.
