

Loranger. Q.C. B. at Ste. Anne d'Yamachiche, P.Q., 10 April 1837. Ed. in Montreal. M., 3 Oct. 1867. Marie Annie Rosalie, dau. of Hon. Justice Laframboise, of the Superior Court, by Marie Rosalie Dessaulles. Called to the Bar, L.C., 1858. Has been a mem. of the Council and is now one of the Examiners of the Bar of Montreal. Has been an Alderman of Montreal. Is Vice-Presdt. of the Société de St. Jean de Baptiste, and was elected Presdt. of the Special Committee appointed to superintend the grand national demonstration, 1874. Apptd. Attorney General in the Cabinet of Hon. Mr. Chapleau, 31 Oct. 1879. First returned to Parlt. for present seat at g.e. 1875; again at g.e. 1878, by acclamation; on accepting office of Attorney General, by acclamation; and also at last g.e. A Conservative and a Protectionist.—344 Craig Street, Montreal.

LYNCH, Hon. WILLIAM WARREN, B.C.L. (Brome.)

Of Irish parentage. B. in Bedford, P.Q., 30 Sept. 1845. Ed. at Stanbridge Academy, Vermont University and at McGill University, at which latter institution he took the Elizabeth Torrance gold medal for proficiency in Roman law, and graduated B.C.L. in 1868. M., 25 May 1874, Ellen Florence, eldest dau. of J. C. Pettes, Esq., of Knowlton. Called to the Bar, L.C., June 1868. Mayor of the Township of Brome and Warden of the County of Brome. Was editor of the *Observer* (Cowansville) for a short period, and has held the Presidency of the Provl. Assn. of Protestant Teachers of Quebec. First returned to Parlt., for present seat, by acclamation at g.e. 1871; re-elected by acclamation at g.e. 1875; again returned g.e. 1878, again in Nov. 1879, on his being appointed Solicitor General, and at last g.e. A Conservative.—*Knowlton, P. Q.*

MARCHAND, Lieut. Col. Hon. FELIX GABRIEL, N.P. (St. Johns.)

A Notary Public; Lieut. Col. commanding 21st Batt. Richelieu Light Infantry. Editor and proprietor *Le Franco-Canadien* newspaper. Elected a mem. of the Executive of the Reform Assn. of the Parti National of Montreal, 1875. Is author of *L'Erreur n'est pas compte* (Quebec 1873), and of other dramatic pieces. Apptd. Provl. Secy. 8 March 1878. Resigned Oct. 1879. First returned to Parlt. for present seat at g.e. 1867; re-elected by acclamation at g.e. 1871; again returned at g.e. 1875, at g.e. 1878, by acclamation, and at last g.e. by acclamation. A Liberal.—*St. Johns, P.Q.*
