

License or Commission to practise as a Physician or Surgeon, shall in addition to a proper knowledge of his mother tongue, be also well versed in the Latin language, and shall, on application for such License or Commission, be examined in his knowledge thereof, before the Board of Examiners, to be appointed in virtue of this Act.

IV. And be it further enacted by the authority aforesaid, that every person being a Student in Medicine, Surgery and Pharmacy, hereafter applying for a License or Commission to practise as a Physician or Surgeon, shall, before he is entitled to obtain the same, be of lawful age of majority, and have served a regular and continued apprenticeship, of at least five years, with some Licensed and regular Physician or Surgeon, practising as such in this Province.

V. Provided always and be it further enacted by the authority aforesaid, that any person who may have taken a degree as a Physician or Surgeon, in any University or College of Surgeons, in Europe or America, may be Licensed and Commissioned as a Physician or Surgeon, in this Province, without an examination as aforesaid.

VI. Provided always and be it further enacted by the authority aforesaid, that no Physician or Surgeon, Commissioned or acting as such in His Majesty's Army or Navy, shall be held to undergo an examination as aforesaid, nor be held or obliged to have a License or Commission in order to practise as a Physician or Surgeon in this Province.

VII. And be it further enacted by the authority aforesaid, that from and after the passing of this Act, no person shall practise as an Apothecary, Chymist, Druggist, or Vender or Retailer of Medicines in this Province, unless he shall have served a regular and continued Apprenticeship, with some Physician, Apothecary, Chymist, Druggist, or Vender or Retailer of Medicines in this Province, for at least three years, and have obtained a License from the Governor, Lieutenant-Governor or person administering the Government of the Province for the time being, after examination before the Board of Examiners as aforesaid, to be established, and being found in every respect a fit and proper person to be Licensed as such.

VIII. Provided always, and be it further enacted by the authority aforesaid, that nothing in this Act contained shall be construed to prevent Retailers or others, from selling any Drugs for which a Royal Patent has, or shall have been obtained.

*And be it further enacted by the authority aforesaid, that every person who may have taken a degree as a Physician or Surgeon, in any University or College of Surgeons, in Europe or America, may be Licensed and Commissioned as a Physician or Surgeon, in this Province, without an examination as aforesaid.*

*And be it further enacted by the authority aforesaid, that no person shall practise as an Apothecary, Chymist, Druggist, or Vender or Retailer of Medicines in this Province, unless he shall have served a regular and continued Apprenticeship, with some Physician, Apothecary, Chymist, Druggist, or Vender or Retailer of Medicines in this Province, for at least three years, and have obtained a License from the Governor, Lieutenant-Governor or person administering the Government of the Province for the time being, after examination before the Board of Examiners as aforesaid, to be established, and being found in every respect a fit and proper person to be Licensed as such.*
