THE CHILDREN'S AID SOCIETY operates along interdenominational lines under the Children's Protection Act of Ontario. It is the only children's agency legally empowered to protect a child from neglect and abuse; to remove him, at once, even from his own parents, if necessary; and to receive him, as a ward, committed to the Society's care, by Court order, until he is 21 years of age.

The Society's budget calls for \$58,000.00 this year, of which the public is asked to provide \$12,000 only, by their contributions, less than \$8.00 for everyone of the 1606 children helped last year.

The Ottawa Day Nursery

Helps the Home to Help the Child

THE DAY NURSERY operating along interdenominational lines, is one of the greatest forces for the preservation of home life in the City of Ottawa. Its activities operate along three major lines.

It offers a safe shelter to the mother, who must leave her little ones, alone during the day, while she seeks the wherewithal to support them. Through the Day Nursery's loving care, she may go about her tasks knowing not only that they are safe and well-cared for, but are also receiving good and necessary home training.

The Day Nursery, through its employment services, also assists the mother in her search for livelihood.



In co-operation with the City, the Day Nursery operates a health clinic that last year gave treatment to 1,728 children, while 5,593 special diet feedings were prepared.

The Day Nursery's budget, apart from the clinic, calls for expenditure of \$12,000.00 to \$13,000.00 of which the public is asked to contribute \$7,000.00.

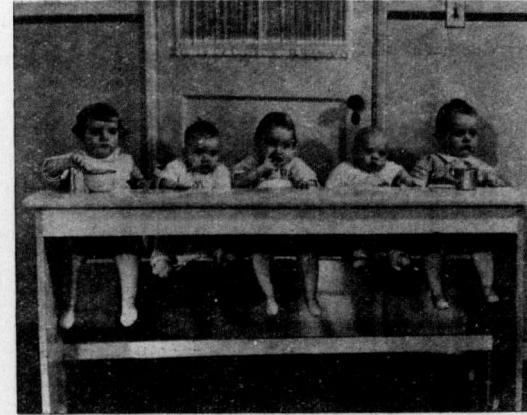
Provides Home Care for the Homeless Child

FOUNDED as the Orphan's Home of the City of Ottawa in 1864, "the Village", with which is now incorporated the Protestant Infants' Home (founded 1915), is the oldest and possibly the most beloved Protestant charity in the City of Ottawa.

In its new and model plant, constructed on the cottage plan principle, it admits to care Protestant infants and children, from birth to the age of 14 years.

The Village has also followed the principle of using the Home as a clearing house only, seeking wherever and as soon as possible, the placing of its children in private family homes. However, unlike the Children's Aid Society, the Village may have many children in care whose need is only temporary,



and often solely of an economic nature. This phase of its work is of the greatest possible value in enabling many homes "to hold together" by thus tiding over the time of greatest need.

The budget calls for expenditure of \$12,500.00 for the year, of which the public is asked to provide \$7,000.00, all of which will be sought from the Protestant Community of Ottawa.

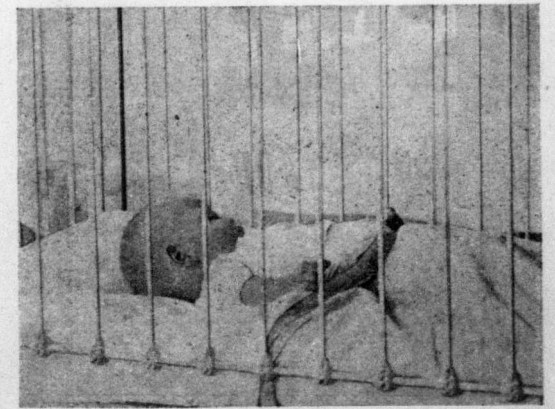

Cares for the Homeless Catholic Infant

IN CO-OPERATION with the Children's Aid Society of Ottawa and the Canadian Council on Child and Family Welfare, the Ecclesiastical authorities of the Episcopal Corporation of the Roman Catholic Archdiocese of Ottawa have decided to open a small home, similar in purpose to the Infant's division of the Protestant Children's Village, for the care of infants of the Roman Catholic faith, whose mothers are bona-fide residents of the city of Ottawa. The opening of this home is necessitated by the closing of the Misericordia Infants' Home.

The capital cost of the undertaking will be met by the Corporation, and only \$3,000.00 of the estimated budget of \$9,000.00 will be raised from the public, all of which will be sought from the Roman Catholic Community of Ottawa.
