TEXTILES—TABLING OF TARIFF BOARD REPORT ON REFERENCE NO. 125

Hon. Donald M. Fleming (Minister of Finance): Mr. Speaker, I wish to table copies in English and in French of the report which I received from the chairman of the tariff board relating to reference No. 125 on textiles. I am tabling also a transcript of the evidence presented to the board at its public hearings.

This report covers a miscellaneous group of tariff items relating primarily to textile products of jute, flax, hemp and other hard fibres. It is the eighth report to be presented by the board pursuant to the textile reference. Two further reports will be required to complete the series. They relate to coated fabrics and to hats and caps.

COLUMBIA RIVER—INQUIRY AS TO CURRENT NEGOTIATIONS

Mr. H. W. Herridge (Kootenay West): Mr. Speaker, I should like to address a question to the Minister of Justice. Can the minister inform the house of any efforts the government has made since the adjournment to reach an agreement with the government of British Columbia with respect to the development of the Columbia river? Is he prepared to make a statement at this time as to the government's position in this stalemated situation?

Hon. E. D. Fulton (Minister of Justice): I thank the hon. member for giving me notice of his intention to ask this question, which,

however, reached me only just before I came into the house, and did not contain the postscript which he has just added.

May I deal with it as he asked it. He asked whether I could inform the house of any efforts made to reach an agreement with the government of British Columbia on the Columbia river problem. As my hon. friend knows, it has not always been easy for me to establish contact with the premier of British Columbia; therefore I am necessarily forced to rely upon the statements I read in the press of that gentleman's intentions. Naturally enough, as my hon. friend will appreciate, we are assessing the implications of the position taken by the premier and the government of British Columbia, as that position is modified from day to day by further statements that the premier issues. The position of the government of Canada is being considered and I expect will be announced very shortly without any possibility of misinterpretation.
