- 3. Prosecutions under the Bankruptcy Act for offences of an administrative character, whenever necessary, are conducted by the legal advisors of the federal Department of Justice in Montreal.

- 6. The expression "fraudulent bankruptcy" may be used to refer to a wide variety of undesirable situations. It may refer to irregularities on the part of debtors, creditors, inspectors, trustees or any other persons having some connection with bankruptcies. During the course of 1966, the office of the superintendent of bankruptcy, in some cases with the assistance of the R.C.M. Police, initiated in the metropolitan Montreal area more than 200 investigations into alleged irregularities connected with bankruptcies on the part of bankrupts, creditors, inspectors, trustees or other persons. This figure does not include investigations carried on by the provincial authorities or the Montreal municipal police or by trustees.
