**Hon. Mitchell Sharp (Acting Prime Minister):** Mr. Speaker, the United States and Canada were discussing the subject of energy until the emergence of the emergency measures taken by the United States which gave some priority to other matters. I do understand that the United States would like to return to having some discussion, but I want to repeat what I said yesterday, that this has no relation whatever to the 10 per cent surcharge.

REQUEST BY UNION CATHOLIQUE DES CULTIVATEURS FOR IMMEDIATE ASSISTANCE TO PREVENT BANKRUPTCY OF CERTAIN PRODUCERS

I can assure the hon. member that the Department is considering this document. The Minister will be back tomorrow from a trip to Europe and will be in a position to inform the parties concerned about the position that the government intends to take on this subject.
