By putting a floor under the price of wheat and instituting discussions with the provinces to stabilize farm prices, we will do more to encourage that than anything the hon. member suggests.

### MALVERN, ONTARIO, DEVELOPMENT—REDUCTION AND HOLDING OF MORTGAGE INTEREST RATES— GOVERNMENT POSITION

### ALLEGED REFUSAL OF TREASURY BOARD TO MEET VETERINARIANS—MINISTERS' POSITION

**Mr. Claude Wagner (Saint-Hyacinthe):** Mr. Speaker, I should like to put a question to the President of the Treasury Board.

Since the collective agreement of federal veterinarians working in Quebec expired June last, can the minister say whether it is true that the Treasury Board is refusing them any increase and if such is the case, does he intend to meet personally the veterinarians involved in order to avoid any action affecting meat inspection and control of animal diseases in Quebec?

Hon. C. M. Drury (President of Treasury Board): Mr. Speaker, I can assure the hon. member that the government does not expect any interruption of meat inspection. Negotiations are under way and I feel that they are progressing rather satisfactorily. As I have always main-
