# ROYAL CANADIAN MOUNTED POLICE

REPORTED ILLEGAL SEIZURE OF M.V. "PATRICIA"—MOTION UNDER S.O. 43

Mr. Howard Crosby (Halifax West): Madam Speaker, I rise under the provisions of Standing Order 43. The Royal Canadian Mounted Police, presumably with the advice of the Minister of Justice and Minister of State for Social Development (Mr. Chrétien) or the Solicitor General (Mr. Kaplan), made a dramatic seizure of the motor vessel *Patricia* and its cargo of 22 tons of marijuana and arrested its crew off the coast of Nova Scotia.

Reports that the action may have been unlawful are supported by the return of the master to his U.S. residence without a Canadian criminal charge being laid, the transportation home of the Columbia crew at the expense of the Canadian taxpayer, and the disappearance from public view of the illicit cargo valued at \$50 million. To protect the interests of the officers involved, I move, seconded by the hon. member for York North (Mr. Gamble):

That this House direct the Solicitor General or the Minister of Justice to report on all aspects of the seizure on May 31, 1980, of the MV *Patricia*, the arrest of the crew and confiscation of the illicit cargo.
