AIR CANADA—ISSUANCE OF PASSES

Question No. 77—**Mr. Cossitt:**

1. In the past four years, did Air Canada issue passes to persons who have no government connection and, if so (a) what are their names, addresses, the names of the firms or organizations for which each worked and their position (b) in each case, for what reason was the pass issued?

2. Which of the firms or organizations was a (a) private enterprise (b) non-profit or charitable organization?

Hon. Jean-Luc Pepin (Minister of Transport): The management of Air Canada advises as follows:

1 and 2. The issuance of free and reduced rate transportation by all Canadian airlines is governed by the air transport committee of the Canadian Transport Commission under the Aeronautics Act. Air Canada's practice in the application of these passes is similar to other Canadian carriers and the airline regards details of its promotional pass issuance as proprietary.
