# TRANSMITTAL OF FAMILY FARMS—GOVERNMENT POSITION

Knowing the difficulties experienced in property transfers, such as a farm transmitted from father to one of his children, particularly with respect to tax matters, I would like to know what measures he will take to improve the situation and make it easier to transfer family farms from one generation to the next.
