COMMUNICATIONS

Mr. Lyle Dean MacWilliam (Okanagan—Shuswap): Madam Speaker, it is my pleasure to rise today and present quite a number of petitions from many parts of British Columbia. They come from communities such as Burnaby, Hundred Mile House, Surrey, Vancouver, Langley, Coquitlam, Pit Meadows, Vernon, Kelowna, Prince George and a number of other locations.

These petitions, which total about 1,040 names, ask the Minister of Communications and this government to oppose UNITEL's bid to compete with Canada's telephone companies in long distance telephone services.

They urge the Minister of Communications to consult with all affected parties, specifically those citizens living outside Canada's main urban centres, who will be impacted very severely by this form of deregulation.

Lastly, they urge the minister to hold local hearings in our communities before deciding the fate of Canada's telecommunications system.
