I indicated to him that I had no objection to that. That being the case, I so move.

The Hon. the Speaker pro tempore: Honourable senators, it is moved by the Honourable Senator Nurgitz, seconded by the Honourable Senator Hastings, that this matter be referred to the Standing Senate Committee on Legal and Constitutional Affairs. Is it your pleasure, honourable senators, to adopt the motion?

Hon. Senators: Agreed.
